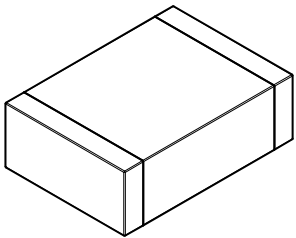

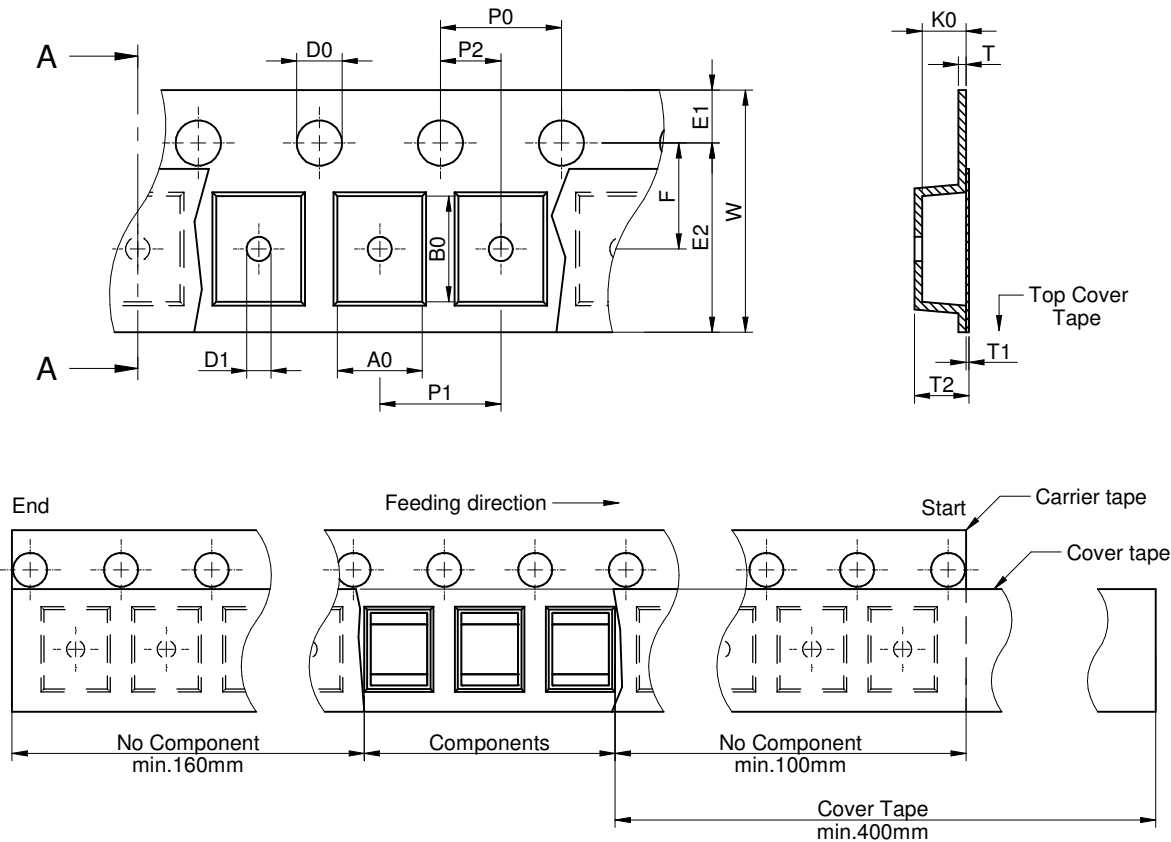

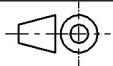
Packaging:
