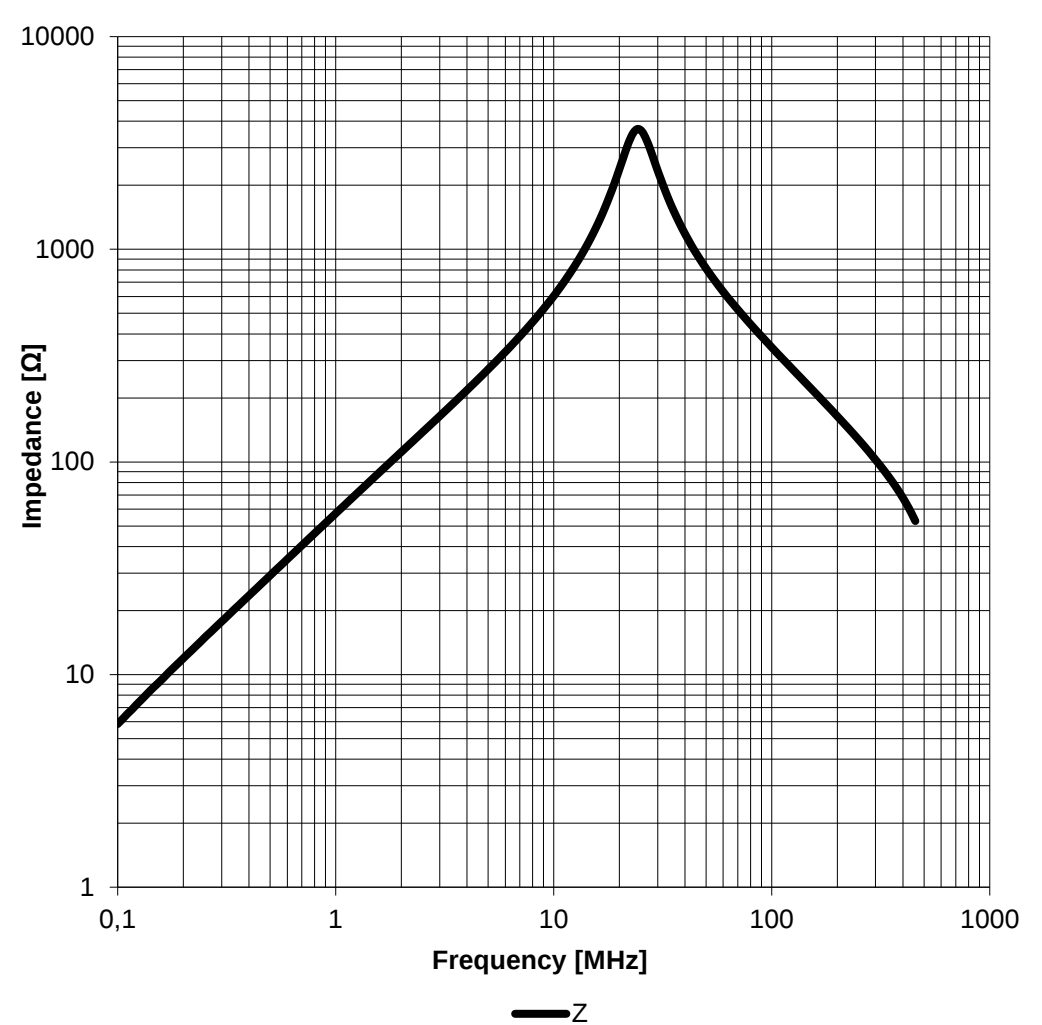

### Soldering:
