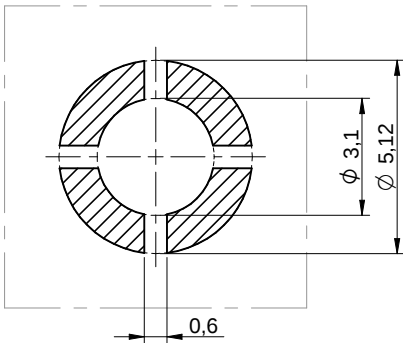
sectional drawing A-A

Soldering:

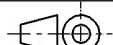
Packaging:

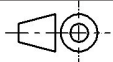
